

ARTICULATION AGREEMENT
Duquesne University of the Holy Spirit (McAnulty College of Liberal Arts) and
Community College of Allegheny County

Duquesne University of the Holy Spirit ("DU"), through its McAnulty College of Liberal Arts ("McAnulty College") and the Community College of Allegheny County ("CCAC") recognize the need for and importance of facilitating a formal Articulation Agreement ("the Agreement") to expedite and simplify the process by which students may transfer from CCAC to DU and apply academic credit earned at CCAC towards completing a Bachelor of Arts (BA) or Bachelor of Science (BS) degree with any major in the McAnulty College. The Agreement supports and enhances the respective missions and values of both institutions.

Terms of Agreement:

Duquesne University will accept CCAC coursework as transfer credit to be applied toward DU baccalaureate degree program requirements under the terms of this agreement and provided the coursework is equivalent to DU coursework or general elective credit. This agreement applies only to students transferring into the McAnulty College. Some professional schools and programs have restrictions on the applicability of transfer credits to professional coursework.

CCAC Students Completing the Associate of Arts or Associate of Science Degree
Upon successful completion of the Associate's Degree ("AD") in either Arts or Sciences and satisfactory completion of the admission requirements of the McAnulty College, students from CCAC will be admitted into the Bachelor of Arts (BA) or Bachelor of Science (BS) program at DU at the junior level with a maximum of 60 transfer credits applying toward McAnulty College's BA or BS degree program.

Students who plan to pursue a major in Mathematics, Computer Science, Psychology, or Economics must earn a grade of C or better at CCAC in courses required for these DU majors in order to receive transfer credit for the Duquesne University equivalent course/s. In cases where a C or better was not earned, students will be awarded general elective credit at Duquesne.

The admissions requirements include:

- Completion of either an Associate of Arts or Associate of Science degree
- A cumulative GPA of 2.5 or higher,
- Official college transcripts from all institutions attended, and
- Any other Duquesne University transfer admission requirements as described at duq.edu/transfer-requirements.

Students who have successfully completed the AD and who choose to transfer under the terms of this Agreement will be considered to have met the DU Bridges Common Learning Experience ("Bridges") requirements. To fulfill baccalaureate degree requirements, students will be required to complete the requirements of their major and

minor. A minimum of 120 credits is required to earn a baccalaureate degree from Duquesne University, 30 of which must be in residence.

Students may transfer up to 12 of the 60 earned credits of CCAC coursework toward their DU majors (most of which require between 30 and 36 credits) and up to 6 credits toward a minor. Students may apply additional equivalent coursework to remaining program requirements. With careful planning, many students will be able to complete program requirements for the BA or BS degree within two years and/or 60 credits from matriculation.

CCAC Students Not Earning the A.A or A.S. Degree

Completion of an AD is not required for admission to Duquesne University. The transfer of credits for students not earning the AD is subject to Duquesne University's Transfer Credit Policy based on the student's term of admission. Students who have not completed the AD will be required to complete the Bridges requirements as well as the requirements of their major and minor.

This Agreement will be renewed annually on July 1 unless terminated by either party upon one year's notice. In the event that either party terminates the Agreement, DU agrees to honor the terms of the Agreement for all students who were accepted and deposited at DU prior to termination as if the Agreement remained in force for the entire term of the student's program.

We, the undersigned, representing Duquesne University of the Holy Spirit and its McAnulty College of Liberal Arts and the Community College of Allegheny County, hereby agree to abide in good faith by this agreement.
